

# NEVADA

## **Current Transportation Condition:**

- ASCE transportation grade of C-<sup>1</sup>
- 10% of major roads are in poor condition
  - Costing motorists \$544m a year - \$315 per motorists<sup>2</sup>
  - Total of 216 people died on state highways in 2013<sup>3</sup>
- Vehicle travel on NV's highways has increased by 141% from 1990-2013,<sup>4</sup> while the population grew by 130 percent.<sup>5</sup>
- 59% of NV's major highways are congested<sup>6</sup>
  - Traffic congestion costs American motorists \$121b a year in wasted time and fuel<sup>7</sup>

## **Commerce:**

- 78% of the \$53b in commodities delivered annually from sites in Nevada is transported by trucks on the state's highways.<sup>8</sup>

## **Need for Federal Investment**

- 49% Federal share of NV Highway Capital Program<sup>9</sup>
- National Interstate Backlog of \$185.24b on 47,575 miles of interstate.<sup>10</sup>
  - National Highway System (NHS) backlog of \$424.5b on 227,224 miles of the NHS.

## **Prioritizing Bridge Reconstruction and Safety:**

- Increased bridge set aside funding for:
  - Nevada's 34 structurally deficient bridges – 13% are structurally deficient or functionally obsolete<sup>11</sup>

## **Improving Commerce:**

- FY16 dedicated funding for Freight Program: \$18,376,152
- Prioritizing federal spending on interstate for projects in the national economic interest

## **Long-term 6 year Certainty:**

- FY16 total share: \$376,263,312

- 60 projects at risk without federal investment<sup>12</sup>
- Major Projects in jeopardy
  - **Project Neon:** will widen 3.7 miles of Nevada’s busiest freeway, I-15, which will significantly improve traffic flow and safety along the highway I-15 North Part 2 - Packages A,C,D<sup>13</sup>
  - **Boulder City Bypass:** First phase and segment of the I-11 corridor connecting Las Vegas with Phoenix, will be financed primarily with federal funds<sup>14</sup>
  - I-580 Carson City Freeway - Phase 2B-3
  - US 95, Phase 3A - NE and SW Ramps
- Building off NEPA reforms accomplished in MAP-21, DRIVE is cutting red tape and accelerating project delivery to increase NV’s ability to efficiently finish projects.
- DRIVE delivers 6 years of certainty. 12 short term extensions since SAFETEA-LU have impeded on NV’s ability to properly plan and budget for transportation projects.
- DRIVE gives NV the ability to prepare for the next 50 years. With a focus on innovation, NV can better deploy technology to improve the state transportation network.
