A BILL

To amend the Coastal Barrier Resources Act to make improvements to that Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4 (a) **SHORT TITLE.**—This Act may be cited as the
5 “Strengthening Coastal Communities Act of 2022”.

6 (b) **TABLE OF CONTENTS.**—The table of contents for

1 **TITLE I—COASTAL BARRIER**
 2 **RESOURCES ACT AMENDMENTS**

3 **SEC. 101. DEFINITIONS.**

4 Section 3 of the Coastal Barrier Resources Act (16
 5 U.S.C. 3502) is amended—

6 (1) in paragraph (1)—

7 (A) in the matter preceding subparagraph

8 (A), by striking “means” and inserting “in-
 9 cludes”;

10 (B) in subparagraph (A)—

11 (i) in the matter preceding clause (i),

12 by inserting “bluff,” after “barrier spit,”;

13 and

14 (ii) in clause (ii), by inserting “and

15 related lands” after “aquatic habitats”;

16 (C) in subparagraph (B), by inserting “,

17 including areas that are and will be vulnerable

18 to coastal hazards, such as flooding, storm

1 surge, wind, erosion, and sea level rise” after
2 “nearshore waters”; and

3 (D) in the matter following subparagraph
4 (B), by striking “, and man’s activities on such
5 features and within such habitats,”;

6 (2) by redesignating paragraphs (5) through
7 (7) as paragraphs (6) through (8), respectively; and

8 (3) by inserting after paragraph (4) the fol-
9 lowing:

10 “(5) OTHERWISE PROTECTED AREA.—

11 “(A) IN GENERAL.—The term ‘Otherwise
12 Protected Area’ means any unit of the System
13 that, at the time of designation, was predomi-
14 nantly composed of areas established under
15 Federal, State, or local law, or held by a quali-
16 fied organization, primarily for wildlife refuge,
17 sanctuary, recreational, or natural resource con-
18 servation purposes.

19 “(B) QUALIFIED ORGANIZATION.—For
20 purposes of subparagraph (A), the term ‘quali-
21 fied organization’ has the meaning given the
22 term in section 170(h)(3) of the Internal Rev-
23 enue Code of 1986.”.

24 **SEC. 102. COASTAL HAZARD PILOT PROJECT.**

25 (a) IN GENERAL.—

1 (1) PROJECT.—The Secretary of the Interior,
2 in consultation with the Assistant Secretary of the
3 Army for Civil Works, the Administrator of the Na-
4 tional Oceanic and Atmospheric Administration, the
5 Administrator of the Federal Emergency Manage-
6 ment Agency, and the heads of appropriate State
7 coastal zone management agencies, shall carry out a
8 coastal hazard pilot project to propose definitions
9 and criteria and produce maps of areas, including
10 coastal mainland areas, which could be added to the
11 John H. Chafee Coastal Barrier Resources System
12 established by section 4(a) of the Coastal Barrier
13 Resources Act (16 U.S.C. 3503(a)) that are and will
14 be vulnerable to coastal hazards, such as flooding,
15 storm surge, wind, erosion and sea level rise, and
16 areas to which barriers and associated habitats are
17 likely to migrate or be lost as sea level rises.

18 (2) NUMBER OF UNITS.—The project carried
19 out under this section shall consist of the creation
20 of maps for at least 10 percent of the System and
21 may also identify additional new System units.

22 (b) REPORT.—

23 (1) IN GENERAL.—Not later than 2 years after
24 the date of enactment of this Act, the Secretary
25 shall submit to the Committee on Environment and

1 Public Works of the Senate and the Committee on
2 Natural Resources of the House of Representatives
3 a report describing the results of the pilot project
4 and the proposed definitions and criteria and costs
5 of completing maps for the entire System.

6 (2) CONTENTS.—The report shall include a de-
7 scription of—

8 (A) the final recommended maps created
9 under the coastal hazard pilot project;

10 (B) recommendations for the adoption of
11 the final recommended maps created under this
12 section by Congress;

13 (C) a summary of the comments received
14 from the Governors of the States, other govern-
15 ment officials, and the public regarding the
16 definitions, criteria, and draft maps;

17 (D) a description of the criteria used for
18 the project and any related recommendations;
19 and

20 (E) the amount of funding necessary for
21 completing maps for the entire System.

22 (c) CONSULTATION.—The Secretary shall prepare the
23 report required under subsection (b)—

1 (1) in consultation with the Governors of the
2 States in which any newly identified areas are lo-
3 cated; and

4 (2) after—

5 (A) providing an opportunity for the sub-
6 mission of public comments; and

7 (B) considering any public comments sub-
8 mitted under subparagraph (A).

9 **SEC. 103. JOHN H. CHAFEE COASTAL BARRIER RESOURCES**

10 **SYSTEM.**

11 (a) **TECHNICAL AMENDMENTS.**—Section 4 of the
12 Coastal Barrier Resources Act (16 U.S.C. 3503) is
13 amended—

14 (1) in subsection (a), in the matter preceding
15 paragraph (1), by inserting “as System units and
16 Otherwise Protected Areas” after “generally de-
17 picted”; and

18 (2) in subsection (f)(2), in the matter preceding
19 subparagraph (A), by striking “copy of the map”
20 and inserting “notification of the availability of the
21 map”.

22 (b) **EXCESS FEDERAL PROPERTY.**—Section 4(e) of
23 the Coastal Barrier Resources Act (16 U.S.C. 3503(e))
24 is amended by adding at the end the following:

1 “(3) DEFINITION OF UNDEVELOPED COASTAL
2 AREA.—Notwithstanding section 3(1) and subsection
3 (g), in this subsection the term ‘undeveloped coastal
4 barrier’ means any coastal barrier regardless of the
5 degree of development.”.

6 **SEC. 104. NONAPPLICABILITY OF PROHIBITIONS TO OTH-**
7 **ERWISE PROTECTED AREAS AND STRUC-**
8 **TURES IN NEW ADDITIONS TO THE SYSTEM.**

9 Section 5 of the Coastal Barrier Resources Act (16
10 U.S.C. 3504) is amended—

11 (1) in subsection (a), in the matter preceding
12 paragraph (1), by inserting “subsections (c) and (d)
13 and” after “Except as provided in”; and

14 (2) by adding at the end the following:

15 “(c) APPLICABILITY TO OTHERWISE PROTECTED
16 AREAS.—Consistent with the Coastal Barrier Improve-
17 ment Act of 1990 (Public Law 101–591; 104 Stat. 2931),
18 except for limitations on new flood insurance coverage de-
19 scribed in section 1321 of the National Flood Insurance
20 Act of 1968 (42 U.S.C. 4028), the prohibitions on Federal
21 expenditures and financial assistance described in sub-
22 section (a) shall not apply within Otherwise Protected
23 Areas.

24 “(d) PROHIBITIONS AFFECTING EXISTING INSUR-
25 ABLE STRUCTURES WITHIN THE SYSTEM.—

1 “(1) IN GENERAL.—With respect to additions
2 to the System made on or after the date of enact-
3 ment of the Strengthening Coastal Communities Act
4 of 2022 but subject to paragraphs (2) and (3), the
5 prohibitions on new expenditures and new financial
6 assistance under subsection (a) shall take effect on
7 the date that is 1 year after the date on which the
8 addition to the System was made.

9 “(2) EXISTING STRUCTURES.—

10 “(A) IN GENERAL.—An insurable structure
11 described in subparagraph (B) shall remain eli-
12 gible for new Federal expenditures and new
13 Federal financial assistance.

14 “(B) INSURABLE STRUCTURE DE-
15 SCRIBED.—An insurable structure referred to in
16 subparagraph (A) is an insurable structure that
17 is—

18 “(i) located within a new addition to
19 the System made on or after the date of
20 enactment of the Strengthening Coastal
21 Communities Act of 2022; and

22 “(ii) in existence before the expiration
23 of the applicable 1-year period described in
24 paragraph (1).

1 “(3) INSURABLE STRUCTURES IN OTHERWISE
2 PROTECTED AREAS.—Notwithstanding any other
3 provision in this section, new Federal expenditures
4 and financial assistance may be provided for insur-
5 able structures in Otherwise Protected Areas that
6 are used in a manner consistent with the purpose for
7 which the area is protected.”.

8 **SEC. 105. REQUIRE DISCLOSURE TO PROSPECTIVE BUYERS**
9 **THAT PROPERTY IS IN THE COASTAL BAR-**
10 **RIER RESOURCES SYSTEM.**

11 Section 5 of the Coastal Barrier Resources Act (16
12 U.S.C. 3504) (as amended by section 104(2)) is amended
13 by adding at the end the following:

14 “(e) DISCLOSURE OF LIMITATIONS.—Not later than
15 2 years after the date of enactment of the Strengthening
16 Coastal Communities Act of 2022, the Secretary, in con-
17 sultation with the Secretary of Housing and Urban Devel-
18 opment, shall promulgate regulations that, with respect to
19 real property located in an affected community, as deter-
20 mined by the United States Fish and Wildlife Service, that
21 is offered for sale or lease, require disclosure that the real
22 property is located within a community affected by this
23 Act.”.

1 **SEC. 106. EMERGENCY EXCEPTIONS TO LIMITATIONS ON**
2 **EXPENDITURES.**

3 Section 6(a)(6) of the Coastal Barrier Resources Act
4 (16 U.S.C. 3505(a)(6)) is amended by striking subpara-
5 graph (E) and inserting the following:

6 “(E) Emergency actions necessary to the
7 saving of lives and the protection of property
8 and the public health and safety, if such actions
9 are performed pursuant to sections 402, 403,
10 407, and 502 of the Robert T. Stafford Dis-
11 aster Relief and Emergency Assistance Act (42
12 U.S.C. 5170a, 5170b, 5173, 5192) and are lim-
13 ited to actions that are necessary to alleviate
14 the emergency.”.

15 **SEC. 107. IMPROVE FEDERAL AGENCY COMPLIANCE WITH**
16 **COASTAL BARRIER RESOURCES ACT.**

17 (a) **IN GENERAL.**—Section 7(a) of the Coastal Bar-
18 rier Resources Act (16 U.S.C. 3506(a)) is amended—

19 (1) by striking “the Coastal Barrier Improve-
20 ment Act of 1990” and inserting “the Strengthening
21 Coastal Communities Act of 2022”; and

22 (2) by striking “promulgate regulations” and
23 inserting “revise or promulgate regulations and
24 guidance, as necessary.”.

25 (b) **TECHNICAL CORRECTION.**—Section 3(2) of the
26 Coastal Barrier Resources Act (16 U.S.C. 3502(2)) is

1 amended by striking “Committee on Resources” and in-
2 serting “Committee on Natural Resources”.

3 **SEC. 108. AUTHORIZATION OF APPROPRIATIONS.**

4 Section 10 of the Coastal Barrier Resources Act (16
5 U.S.C. 3510) is amended by striking “\$2,000,000” and
6 all that follows through the period at the end of the sen-
7 tence and inserting “\$5,000,000 for each of fiscal years
8 2023 through 2027.”.
